ORDER ON COBB EMC'S MOTION TO STAY


The above-referenced Motion having come before the Court for hearing, and after considering the briefs and arguments of counsel, this Court **ORDERS** as follows:

1. Defendants shall answer on or before January 3, 2008.
2. By January 24, 2008, the parties (individually or, to the extent they can agree, jointly) shall submit a proposed discovery plan or plans. In formulating such

plan(s), the parties shall be guided by the Civil Local Rules for the United States District Court for the Northern District of Georgia.

- 3. The discovery period in this case shall begin on February 4, 2008.
- 4. With respect to discovery, the parties and the Court shall be guided by the Federal Rules of Civil Procedure provisions on electronic discovery.
- 5. The Court appoints Senior Judge Michael Stoddard as Special Master to hear and rule on any discovery disputes subject to modification by the Court.




